

Huntington Parish Council

General Meeting 11th July 2023

7.30pm Huntington village Hall

Minutes

Present: Mr BH James, Mr G Jones, Mr G Meakins and Mr MA Lloyd

Apologies were received from Mr P Williams, and Mr G Steel would be joining the meeting later.

Minutes of the previous meeting held on 30th May 2023 were read and approved, proposed by Mr G Jones seconded by Mr G Meakins and carried unanimously.

Matters arising: There were no matters arising.

Footpath at Llanarrow: Mr Lloyd informed councillors that Mr R Luscombe had applied to move a footpath from going around the front of his property to being moved to the rear of the property. The new path would be passing through land owned by Mr R Hammond. A copy of a letter received from Mr R Hammond agreeing that the footpath could be moved over onto his land, together with plans showing the existing and proposed footpaths were shown to councillors.

In Mr Hammonds letter he set out the conditions which should be applied to the diversion of the footpath in order for him to accept the change of the route of the footpath:-

"The new route should not go through the existing gates that are at the end of the drive and into the adjoining field, but should be new self closing galvanized footpath gates inserted in the existing fence. The footpath gate on the driveway should be in the fence line between the gates that are in the side of the driveway and the gate that is across the drive into the property. The footpath gate into the adjoining field should be in fence between the existing gate and the fence at the back of the property. In both cases the existing fence should have posts and stays both sides of the footpath gates to ensure that there is no strain on the footpath gates. The diversion should re-join the existing path at the location given by whatsdapp 3 words graphics.remaining.musical. Any costs incurred in diverting the footpath should be wholly covered by Roger Luscombe".

After discussion and consideration of the maps provided together with Mr Hammond's letter, Mr B James proposed that the Parish Council did not have any objections to moving the footpath at Llanarrow as long as the conditions set out by the landowner MR R Hammond are met. Seconded by Mr G Meakins and carried unanimously.

Mr Lloyd to advise Mr Luscombe of the Parish Council's decision.

The Parish Council had received notification that Haygrove had applied to amend the two existing planning applications relating to increasing the acreage of cherry trees under poly tunnels, and the siting of 18 mobile homes on the land off Mahollam road.

After discussion it was felt that the new amended planning applications did not alter materially from the original applications.

Mr B James proposed that as the Parish Council had already made a number of objections to the original planning applications and that there were not any new grounds in the amended applications that the Parish Council could not raise further objections. Seconded by Mr G Jones and carried.

Mr Lloyd reminded Parish Councillors to complete and return their Election expenses forms To Herefordshire Council even if they did not have a claim to

There being no other business the meeting closed at 9.35pm.
